Hearing Forest Murmurs from Wagner's Siegfried on the radio recently set me wondering how many composers have been inspired by woodlands in various ways. Pieces such as Forest Scenes (Schumann), November Woods (Bax) or From Bohemia's Woods and Fields (Smetana) may come to mind or, in a lighter vein, A Walk in the Black Forest – of which I still have Horst Jankowski's original 45 rpm Mercury single from 1965 tucked away somewhere!

The idea of walking through the woods, though, has something of a parallel with our present situation. As life begins to return to something like normality after lockdown it's a bit like coming to the end of a forest walk; the trees are beginning to thin out and we can see a bit more daylight, but we're not out of the wood yet and some have fallen by the wayside. Nevertheless, although some societies have, regrettably, had to close, others are now beginning to meet again, albeit with precautions, and the FRMS Committee has produced some fresh guidance which can be found in this Newsletter - on what measures may be necessary in order to meet safely.

So, as we begin to pick up the pieces may I, on behalf of the Committee, send best wishes to all societies.

Covid-19 - Guidance on Resuming Meetings

Advice to societies on resuming meetings following the lifting of Covid-19 restrictions.

On 19th July, the UK Government confirmed the move to step 4 of their Covid-19 recovery roadmap. This removes the vast majority of the previous legal requirements. Nevertheless, as infections continue to rise, the Government recommends continuing caution. The following are all noted as beneficial:

- good ventilation;
- diligence in hygiene;
- wearing a face covering in enclosed and crowded spaces;
- minimising the number, proximity and duration of social contacts with those we do not live with.

In the light of this, the Federation considers that it is both sensible and appropriate for societies to take some measures to limit the spread of Covid-19. Societies have a Duty of Care, i.e. a responsibility to protect their members and other users of the premises where they meet. However, it is now down to each society to determine for itself what measures should be taken. It is to some extent fortunate that most, if not all, societies meet on premises which are owned and managed by others and that therefore the overall responsibility for the safe operation of the premises does not lie with societies. The onus on societies is to act in accordance with any restrictions which the owners of the premises may consider necessary. We suggest that it is sensible to discuss with the owners what measures, from those given in the risk assessment template* are appropriate in their situation. The template is based on one drawn up by Swinton Recorded Music Group in conjunction with the Church where they meet, and we are grateful to Swinton RMG for making the original available to us.

We are aware that the age profile of many societies means that in any society there are those who consider themselves vulnerable and are therefore still reluctant to attend meetings; on the other hand, there are members who are keen to return to normal as quickly as possible. Hence making decisions on resuming meetings has the potential to be divisive. In some respects, it was easier when rules were more restrictive but at least definite. *Continued on the next page* How we make decisions may prove to be as important to societies, and their future survival, as the decisions themselves. Members should listen to each other and compromise as necessary.

NB. These notes are based on the conditions applicable in England. Whilst the general principles will also apply to Scotland and Wales there are differences in the situation in both those countries which may affect the ability of societies there to resume meetings.

AGM 2021

Last year, as we know all too well, the UK and the world found itself in the grip of the coronavirus pandemic and our planned AGM in



Leicester was replaced with an online meeting using a videoconferencing application called Zoom. It is certainly true that there is no cloud without a silver lining: the online meeting allowed a much wider geographical range of societies to attend and it provided a productive platform for discussion and interaction. And all in the comfort of our own homes!

This year is ostensibly different and, over the past few months, we have seen most legal restrictions lifting and life gradually returning to something closer to normality. The vaccination programme has given many people a feeling of greater confidence in attending public gatherings. However, the situation remains volatile and we, as a national committee, feel that it would be irresponsible to attempt to return to a live AGM this year, given a significant degree of uncertainty about the months ahead and the potential for another rise in infections during the winter. I recently conducted a survey with affiliate societies and there was a very strong majority in favour of another online meeting this year.

Therefore, this year's AGM will take place remotely on Zoom with the Leicester AGM postponed again to 2022.

The Zoom technology will allow everyone who has an internet connection to be involved and it really is very easy to use. It costs nothing and all you do is submit an email to me – using the form in the AGM invitation letter – and our Webmaster will then ensure that you

are sent an electronic invitation. The Zoom display looks very much like the picture you can see here from last year's meeting.



I do hope that as many of you as possible will be able to join us. In addition, joining the Federation committee has never been easier as all our meetings will now be held in this way. There are two vacancies on the committee, so please do think seriously about joining us.

I look forward to seeing as many of you as possible on **6 November at 2pm.**

Mick Birchall

It is with sadness we have to announce the passing of Mick Birchall recently. Mick was born, grew up, lived and worked in the Leicestershire village of Desford. He was, though, an inveterate traveller, visiting many parts of Europe and notably Italy; his love of Italy extended to its music and arts (he was a member of the Dante Alighieri Society) as well as its cuisine. Nevertheless, he was also an enthusiast for English music, particularly that from before the 19th Century, which he felt was unfairly neglected.

Mick was first elected to the FRMS Committee in 2001 and was its longest-serving member when he stepped down at the last AGM. He was Vice-Chairman for a time but his greatest contribution to the Federation has been his many years of service as minutes secretary, keeping scrupulously accurate records of the Federation's business. Mick's involvement with the FRMS was not limited to the national Committee, however. He was Secretary of Hinckley RMS, a member of Northampton RMS and, until its closure, a member of Spalding Music Club. Many members of societies in central England will remember regional music days for which he was not only one of the organisers, but was often the caterer too!

Mick is survived by a brother and sister, to whom we extend our sympathy.
